APPLICATION FOR WATER SERVICE

The undersigned, in applying for water service at the location described below, agrees to pay for the service at applicable rates set by the Board of Directors of the Foresthill Public Utility District. The applicant further agrees to abide by the Rules and Regulations of the District, a copy of which is available for inspection at the District's business office. **NOTE: The District water lines run up to the meter only. Water lines from the meter to the dwelling are the responsibility of the property owner.**

Bills for water service are issued on the first day of the month and are due and payable upon receipt. Any unpaid balance is considered delinquent and subject to penalties after the 20th of each month. Penalties are 10% of the balance. Balances more than 60 days overdue are assessed penalties at the rate of 0.5% of the balance. Water rates are based on monthly usage (15th to 15th). Monthly rate total for a meter under 1" is \$80.33 for 0 – 10,000 gallons. A credit of \$.38 for every 1,000 gallons not used will be applied. Water usage over monthly minimum rate is billed at \$1.37 per 1,000 gallons. After one year of good payment history (no penalties) the deposit is refunded.
