In addition, I hereby release and discharge the FORESTHILL PUBLIC UTILITY DISTRICT, its agents, officers, and employees from all actions, claims, and demands that I, my heirs, guardians, legal representatives or assigns now have or may hereafter have for injury or damage resulting from my participation in these volunteer activities or services.
